# What Is the NEBOSH Level 6 Diploma?

The **NEBOSH Level 6 Diploma** is a flagship course regarded as the gold standard of workplace health and safety training.

In a nutshell, this internationally recognised qualification is the highest-level qualification for people who want to become top-notch experts in occupational safety and health.

Renowned for its extensive syllabus, it covers a wide range of topics, including safety laws and regulations, assessing and managing workplace risks, and influencing safety culture at all levels of an organisation.

## Course Duration:

- ▶ **Online/Distance:** 415 hours
- ▶ **Virtual/Classroom:** 6 split weeks (30 working days).

## Entry Requirements:

- ▶ No formal requirements, but it's recommended you complete the **NEBOSH General Certificate**.

This course is well-known for being very challenging, even for the more practised members of the profession. We recommend that learners view the course as a sizable investment of time and effort, likening it to the structure and difficulty of an Honours Degree in the UK.

## Who Is the Course For?

The course is built specifically for anyone with an ambition to progress their career in health and safety. It's just right for people already working in health and safety who want to build on their competency, including:

- ▶ Health and Safety Managers, Advisors or Officers
- ▶ Compliance Managers
- ▶ Engineers

# National vs International Versions

## How Do They Differ?

There are two versions of the NEBOSH Level 6 Diploma available:

- ▶ **NEBOSH Level 6 National Diploma** for Occupational Health and Safety Management Professionals
- ▶ **NEBOSH Level 6 International Diploma** for Occupational Health and Safety Management Professionals

The only difference between the two is in the specific legislation and laws mentioned in the content.



**The NEBOSH National Diploma** is specific to the UK, so it'll help make sure you're working to UK standards, laws and regulations, e.g. Health and Safety at Work etc. Act 1974.



**The NEBOSH International Diploma** uses worldwide examples because it focuses on best practice and international guidelines set by regulating organisations such as the International Labour Organisation (ILO) codes of practice.

**Assessments****DN1 / DI1 – Assignment**

**This assessment is split into two papers:**

- ▶ The first paper will present you with a health and safety management scenario, and you will be required to complete a set of improvement tasks connected to that scenario.
- ▶ The second paper will be based on a real workplace, so learners can elect to use their own workplace or a suitable alternative.

**DN2 / DI2 – Case Study**

A scenario-based case study assessment requiring you to analyse a workplace situation and apply your knowledge to identify and control health risks. You will be required to apply the knowledge you have gained throughout the course.

**DN3 / DI3 – Case Study**

Another scenario-based case study assessment requires you to identify and control safety risks, based on a real-world situation, in which you will need to apply the knowledge you have gained from the course.

Upon successful completion of the NEBOSH Level 6 Diploma, you will be able to:

- 1 Source, develop, evaluate and interpret relevant health and safety information, such as legislation, best practices and procedures and communicate effectively to stakeholders at all levels of an organisation.
- 2 Promote a positive health and safety culture by influencing leaders and changing attitudes and behaviour.
- 3 Assess, develop and maintain individual and organisational health and safety competence.
- 4 Understand risk management, including the techniques for identifying hazards, the different types of risk assessment, considerations when implementing sensible and proportionate additional control measures, and developing a risk management strategy.

- 9 Manage contractors and supply chains to ensure compliance with health and safety standards.
- 10 Advise the organisation on a range of common workplace health issues/ hazards, including how these can be assessed and controlled and the legal duties associated with these issues/ hazards.
