### Overview

Learn how to perform internal and external audits of an environmental management system (EMS) against the requirements of ISO 14001 with this ISEP, CQI and IRCA certified ISO 14001 Lead Auditor training course.

- audit to assess conformance with ISO 14001 requirements

The course is built around a central case study that simulates a site audit, giving students practical experience in tackling audit tasks. Workshops, discussions and interactive tutorials cover important topics such as risk-based auditing, assessing environmental aspects and impacts, and EMS nonconformity writing.

Delegates are assessed through a combination of continuous assessment during the course and an online exam after the event.
