# Course Overview

## Learning outcomes

- ▶ Justify fire safety improvements using moral and financial arguments
- ▶ Advise how fires and explosions can occur and the appropriate controls to minimise fire and explosion risks
- ▶ Advise your employer on the requirements for the fire protection of premises and workers including the appropriate training obligations
- ▶ Carry a fire risk assessment in your own workplace – prioritising risks, inspecting the workplace, recognising a range of common fire hazards, evaluating risks (taking account of current controls), recommending further control measures, planning actions

## Course level

The NEBOSH Fire Certificate is a level-3 vocational qualification on the UK Regulated Qualification Framework (RQF) and Qualifications and Credit Framework (QCF). That's like an A-level.

In the Scottish Credit and Qualification Framework (SCQF), it's recognised as a level 6 with 5 credit points.

## Course structure

The NEBOSH Fire Certificate required 56 hours of study. This is split into 28 taught hours, 20 self-study hours, and 8 assessment hours.

# Full Course Syllabus

The NEBOSH Certificate in Fire Safety covers the main principles for managing and improving health and safety in the workplace. It's split into eight modules:

Element 1:

## Managing fire safely

Learning hours: 2

Self study hours: 20

- ▶ Moral and financial reasons for managing fire safety
- ▶ The role of national governments and international bodies in developing frameworks for the regulation of fire safety.

Element 2:

## Principles of fire and explosion

Learning hours: 4

Self study hours: 20

- ▶ The principles of combustion, fire growth and fire spread
- ▶ The ignition of solids, liquids and gases
- ▶ Explosion and explosive combustion.

Element 3:

## Fuel, oxygen, and ignition sources and control

Learning hours: 4

Self study hours: 20

- ▶ Sources of fuel, oxygen and ignition sources
- ▶ Appropriate control measures to minimise fire and explosion risks.

Element 4:

## Fire protection of buildings

Learning hours: 7

Self study hours: 20

- ▶ The means of fire protection and prevention
- ▶ Means of escape
- ▶ The methods and systems available to give early warning of fire
- ▶ Classification of fires, extinguishing media and portable fire-fighting equipment
- ▶ The method of operation and maintenance of fixed installation systems
- ▶ Requirements for ensuring access for the fire service is provided and maintained.

**Safety of people in the event of fire**

- ▶ Fire emergency plan
- ▶ Fire evacuation
- ▶ Behaviours of people in the event of a fire
- ▶ Appropriate training requirements.

**Fire safety risk assessment**

Learning hours: **6**

- ▶ Objectives of fire safety risk assessments
- ▶ Principles and practice of fire safety risk assessments
- ▶ Matters to be considered in a risk assessment of substances capable of forming a flammable or explosive atmosphere.





# Assessment

The NEBOSH Fire Certificate has two assessments: an open book exam and practical risk assessment. You must pass both to achieve your full qualification.

## Unit FSC1: Open Book Exam

Unit FSC1 is assessed with an open book exam which you type and submit online. You'll be asked to carry out a series of tasks which relate back to elements 1-6.

The aim of the exam is to test your ability to apply your learning to the workplace. Your answers should be relevant to the given situation and, when appropriate, reference evidence from it directly.

The overall paper is worth a total of 100 marks.

## Unit FSC2: Practical Risk Assessment

Unit FSC2 is a marked risk assessment. You'll need to demonstrate your practical understanding of elements 2-6 and relate this back to the theory from previous elements.

The risk assessment is split into 4 stages:

- ▶ General information
- ▶ Fire safety audit
- ▶ Summary and action plan
- ▶ Review

Each stage is assessed individually, and you must pass all 4 stages to pass.

## Exam Results

You must pass both assessments to achieve your NEBOSH Fire Management Certificate.

FSC1 is graded and you must achieve at least 45 marks to pass, while FSC2 is marked with a pass or fail. Your overall qualification grade will be awarded to you based on your numerical result from FSC1:

- ▶ Distinction: 75 marks +
- ▶ Credit: 65 - 74 marks
- ▶ Pass: 45 - 64 marks

## Exam Results

NEBOSH will email you your results within 50 working days of submitting your assessment. If you haven't received your results in that time, then contact your course provider and they'll be able to help.

## Exam Dates

**FSC1** open book exams are held throughout the year. You need to register before your chosen exam date at least 5 weeks before.

**FSC2** practical risk assessments can be submitted at various times throughout the year. As with the FSC1, you need to register to submit your practical 5 weeks before your chosen date.
